## Farm Women's Market Update

The Town, along with other communities, has been in continuing discussions with the County Executive, members of the County Council and the staff of the Historic Preservation Commission regarding the proposed Farm Women's Market (FWM) project. Our goal is for this public-private partnership to create a significant park on the existing surface parking lot (Lot 24) just behind the FWM, and we support the vision of an expanded and improved market with more stalls, vendors and eateries. We also want the FWM plaza to help activate this space, with outdoor seating and dining areas facing the new park.

Progress is being made. In particular, the developers have agreed to narrow the apartment building that would extend into the current parking lot, and they are now considering further revisions that would reduce the scale of the planned food retail area, which would leave more area for the park. Further, they do not consider the placement of town homes on the surface parking lot (Lot 10) just south of Leland to be important for their project, and they are prepared to include this area in an expanded park. We strongly support this important modification.

But a great deal of work remains to be done. Numerous issues need consideration, such as planning for the underground garage to replace the surface parking, the location of ramps into and out of the garage and ensuring adequate emergency vehicle access. And, crucially, the budget must be developed. The developers will fund only a portion of the project, and the County will need to cover much of the cost.

Currently, the developers have scheduled a Planning Board review of their Sketch Plan -- the first significant step in the planning approval process -- for the end of May. We'll keep you updated as plans progress. When we have a clearer idea of the proposal to be presented to the Planning Board, we will host another Town forum for residents to see the plans and ask questions.

## Purple Line Construction to Ramp Up

Many of you have noted the additional work recently undertaken to complete the clearing of the Purple Line right-of-way. The contractors are awaiting final plan approval by the Maryland Department of the Environment, but then work will proceed quickly. Over the next six months, the contractors expect to excavate for storm water pipes and to begin constructing noise and retaining walls.

## Public Hearing on Permit Parking Program Changes

At its April 24 meeting, the Town Council will hold a public hearing on several amendments to the Town's permit parking program. The proposed changes include:

- Authorizing the issuance of a second permanent guest card, upon request, to households within a designated permit parking area. This proposed amendment is in response to numerous complaints from homeowners within the Town's permit parking areas that one guest pass is insufficient to accommodate multiple visitors and guests to their residences. Currently, the code allows the issuance of one permanent guest card to each residence within a permit parking area.
- Clarifying that the Town will automatically extend permit parking to an area adjacent to an existing permit parking area only if the required parking study shows that residents have an inability or difficulty in finding on-street parking. The current code language only requires that a study be done, but it does not state that the study must meet any standard.
- Clarifying that the Town Manager is the person authorized to make a finding of "special need" to issue permits for persons not otherwise authorized to receive them. The current code allows these permits to be issued, but it is unclear who evaluates a request for such a permit.
- Reflecting the current practice of issuing parking permits that are valid for two years. The current code language states that permits are valid only for one year.

## Please Obey County Leash Law

The Town office has received calls from residents complaining that dog owners do not observe the County's leash law. Please remember that your dog should always be on a leash when not in a fenced portion of your yard. Even generally well-behaved dogs off leash can be threatening to pedestrians and other dogs on leash. Please observe this law so that everyone can enjoy walks through the Town with or without their dogs.

## Native Canopy & Street Tree Plantings

The Town is preparing its spring tree planting list. If you have a spot in your yard suitable for a canopy tree, you might want to take advantage of the Town's Native Canopy Tree Planting program. Under this program, the Town will purchase and install a canopy tree on your property at no cost to you. Residents are responsible for the long-term care of the tree once installed.



You also may request to have a tree planted along the street in front of your home. The Town prefers to plant canopy trees when possible. Once the trees are planted, the Town will care for the trees for the first year by ensuring that they are watered. ## 2019 Election & Annual Meeting

The Town's election and annual meeting will be held on Tuesday, May 7, 2019. Town residents will select two candidates in the 2019 election, each to serve on the Council for a 2-year term. Information about the nominated candidates will be mailed to all residents 2 weeks before the election, and the Town's Election Board will host a Candidates' Forum on April 30 at 7 p.m. in the Town Hall. The annual meeting will begin at 7 p.m. on May 7 and will include a public hearing on the proposed FY20 budget, which will be available for review on the Town website after April 23.

# TRASH & TREASURES

---

The Town's spring Trash and Treasures is scheduled for the weekend of [April 13 & 14](#). The Town offers this bulk trash pickup so that residents can dispose of items that are no longer usable, such as appliances (doors must be removed for safety), furniture, rolled rugs, mattresses, games and bikes. If the items are usable, we encourage you to review the list of [Alternatives to Trash and Treasures](#) (see reverse). We have tried to give you a variety of options.

## GUIDELINES

- Please remember to bag, box or contain all of your discards.
- Please do not put items on the curb before Friday afternoon, April 12.
- The following items will not be picked up:
  - NO construction debris
  - NO parts of junked automobiles (engines, transmissions), boats or trailers
  - NO loose glass of any kind
  - NO firewood or fencing of any kind
  - NO paint cans
  - NO flammable or hazardous liquids or solids
  - NO recyclable items, such as newspapers, mixed paper or cardboard, landscape pots, old books and magazines, large plastic bins - please recycle!
  - NO shrubbery cuttings, yard clippings, leaves or grass – recycle with yard trash!

If you have questions about how to discard any of these items, please call the Town Office at [301-654-7144](#). We will be happy to help you arrange a special pick-up for items that are not included in Trash and Treasures. There is a charge for a special pickup.

**PICK-UP SCHEDULE:** At 7 a.m., [Monday, April 15](#), a crew will begin clearing feeder streets to Chevy Chase Elementary School. During non-rush hours, the peripheral streets will be cleared. After these priority streets are cleared, the truck will proceed according to a pre-arranged schedule. Once a street has been cleared, the contractor will *not* return to that street. Residents who discard items after the street has been cleared will have to arrange for a special pick-up.

## Hazardous Waste Disposal

The Household Hazardous Waste receiving area at the Shady Grove Solid Waste Transfer Station is located in the recycling drop-off section of the Public Unloading Area, 16101 Frederick Rd, Derwood, MD 20855. Please use the car entrance to the facility. The drop-off is open Monday - Friday, 7 a.m. to 8 p.m.; Saturday, 7 a.m. to 5 p.m. and Sunday, 9 a.m. to 5 p.m. Household Hazardous Waste can only be received during these hours -- please do not drop off this material at other times. Batteries are accepted (alkaline batteries may be put in regular trash) as are fertilizers with herbicides; fluorescent light tubes and bulbs, including CFLs; herbicides; insecticides; mercury containing items; oil-based paints; paint thinners; pesticides; and used motor oil and most other oils. ## Centennial Snipit

### *Celebrating the Town of Chevy Chase: Past, Present & Future*

As the Town of Chevy Chase's year-long Centennial celebration winds down, we look back at past milestone anniversaries and the activities they inspired. Among them, the Fourth of July Picnic and the Town's first cookbook, *Town Chefs of Chevy Chase*, from the 75<sup>th</sup> Anniversary. From the 65<sup>th</sup> Anniversary came *The Town of Chevy Chase Past and Present* organized by the History Committee and written by Town residents. At that time, the History Committee began a Town archives of local documents including maps, photographs, house deeds and more.

Commemorations of the 100<sup>th</sup> Anniversary will include a sculpture in the Lee Dennison Sustainable Garden in Zimmerman Park and oral histories by residents discussing how the Town has been shaped over time by changes in transportation, schools, national events, and more. Also, the Town is collecting items to add to the archives mentioned above and to become part of the virtual time capsule. Some of these items will be on display at the reception for the progressive dinner\* on April 13, the Town's last 100<sup>th</sup> Anniversary celebratory activity. Join your neighbors for the dinner and come to the reception celebrating the 100<sup>th</sup> Anniversary of the Town of Chevy Chase.

\* The first progressive dinner was held in 2009 to mark 100 years of the Town's self-governance, which began in 1909 when a handful of residents on both sides of Connecticut Avenue formed the Chevy Chase Citizens' Association of Section Three and Four.
